

## **SUMMARY ANNUAL REPORT**

### **For NORWICH UNIVERSITY CAFETERIA PLAN**

This is a summary of the annual report of the NORWICH UNIVERSITY CAFETERIA PLAN, EIN 03-0179424, Plan No. 515, for period 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

NORWICH UNIVERSITY has committed itself to pay certain self-funded Medical, and Dental claims incurred under the terms of the plan.

#### **Insurance Information**

The plan has contracts with VISION SERVICE PLAN and UNUM LIFE INSURANCE COMPANY OF AMERICA to pay Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Critical Illness, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$299,096.
